### 1. U2A – Use of GUI **Query Payment transaction** screens

1. 'Standard' Search/Display -> for a single transaction (equivalent to A2A camt.005/camt.006)
2. Advanced Search/List -> for multiple transactions plus (optionally) Details on a selected transaction

Connected User need to be granted in CRDM with *TIP\_Query/TIP\_QueryReachable* privilege

### 2. A2A – Use of **Get Transaction** functionality via XML messages **camt.005/camt.006**

Available to both Originator and Beneficiary PSPs.

TIPS System will check that the Sender DN is authorized to either instruct:

- a QUERY for the debtor or creditor side of the underlying transaction
- a QUERY for the participant represented by the originator or beneficiary of the underlying transaction
- an INSTANT PAYMENT for the debtor or creditor side of the underlying transaction

### 3. A2A – Use of **Investigation** functionality via XML messages **pacs.028/pacs.002**

Available only to Originator PSPs.

TIPS System will check that the Sender DN is either:

- the original transaction originator
- authorized to instruct an Instant Payment for the debtor participant

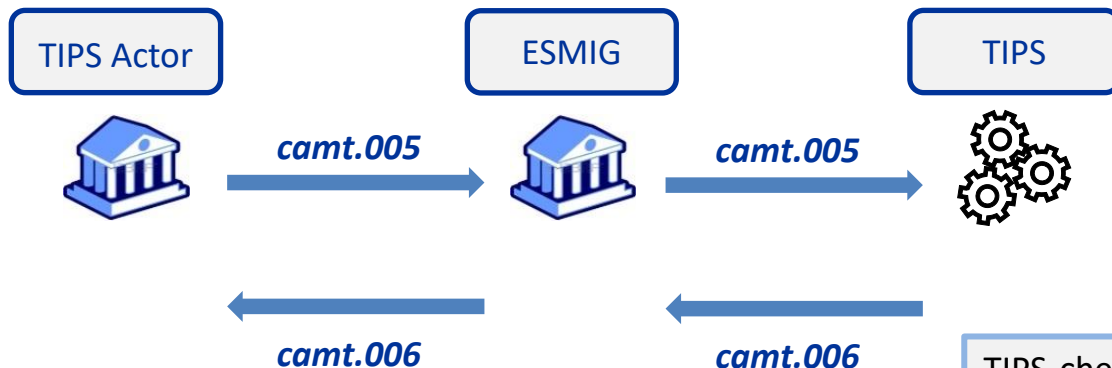

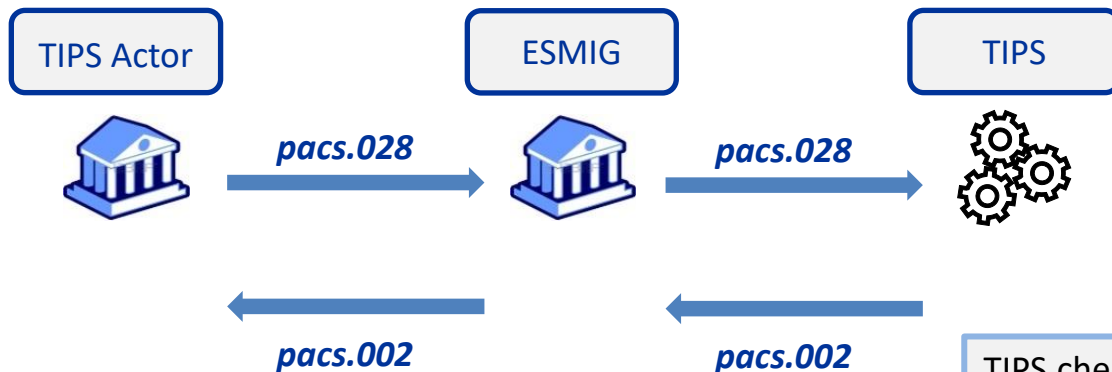
User ABC sends a Get Transaction request via camt.005

ESMIG performs authorization check at service level, to verify whether the Sender DN is enabled to send requests to TIPS

TIPS checks that the user linked to the Sender DN has been granted with the needed privileges and that the queried transaction is in the data scope of the Party the user belongs to. The query results are returned via camt.006

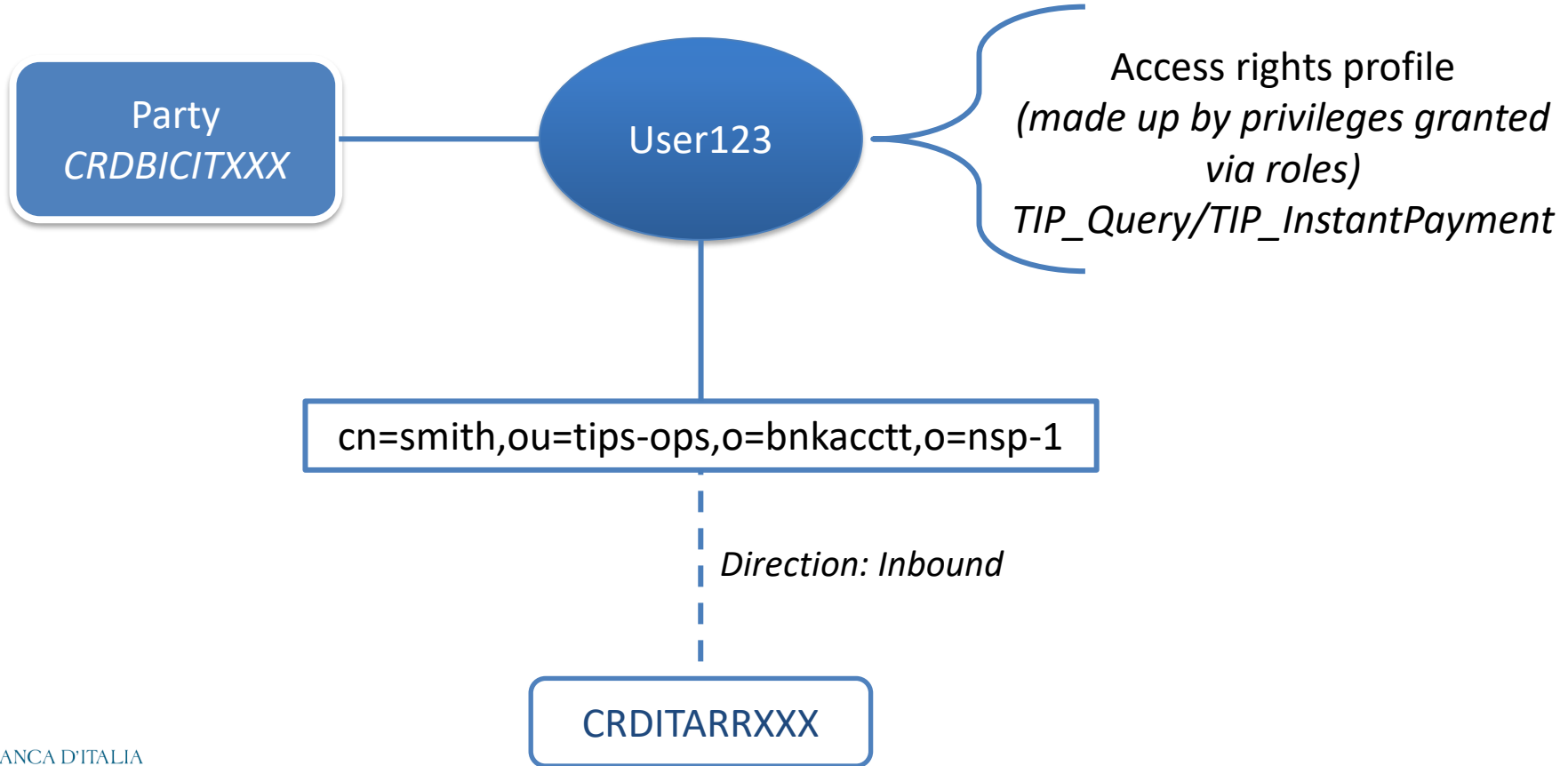

ESMIG performs authorization check at service level, to verify whether the Sender DN is enabled to send requests to TIPS

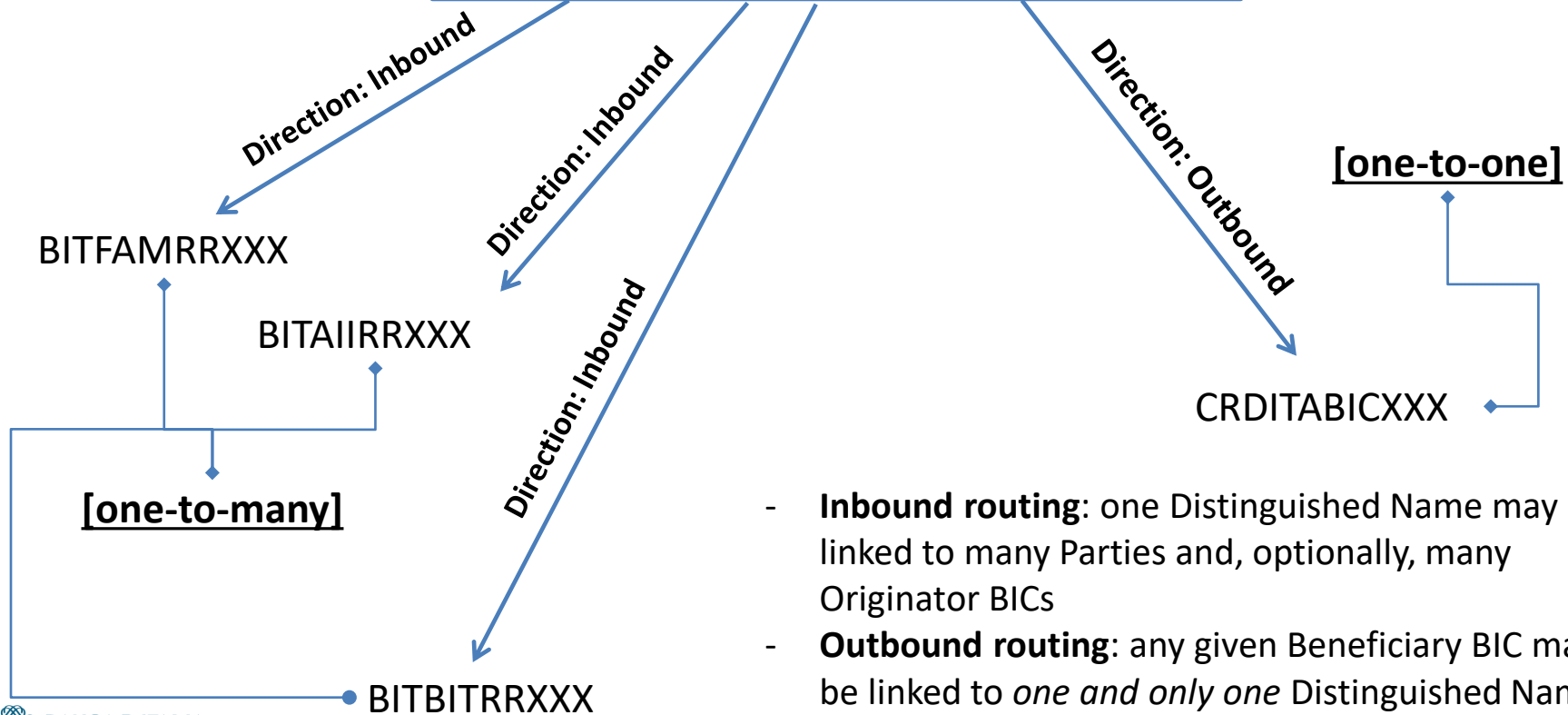

TIPS checks that the Sender DN is the originator of the underlying transaction or the Sender DN is authorized to instruct IPs for the debtor participant. The results are returned via pacs.002





cn=smith,ou=tips-ops, o=bnkacctt,o=nsp-1



- **Inbound routing:** one Distinguished Name may be linked to many Parties and, optionally, many Originator BICs
- **Outbound routing:** any given Beneficiary BIC may be linked to *one and only one* Distinguished Name
