**II.1.5) Short description of the contract or purchase(s)**

The European Central Bank (ECB) is seeking through this open procedure a supplier for the provision of supply of IT End-user Computer Equipment and related Services and intends to award a contract (the "Contract") to the supplier offering the best value for money.

The current End-user IT Computer Equipment being used at the ECB is comprised of laptop and desktop computers, monitors, windows deskside printers and multi-functional peripheral devices (capable of copying, printing and scanning) and related accessories (incl. accessories for mobile equipment like iPhones, iPads etc.).

The standard computing device issued to staff is a slim laptop with a diagonal screen size of approximately 15 inches weighing 1.5 kg. In addition, dependent on laptop model, users are provided with either a so-called "port replicator" or a "docking station" that provides connections for an external monitor (currently wide-screen LCD, 23 inch), keyboard and mouse for use within the office environment. A mini form factor PC (or laptop) is deployed for meeting rooms or non-personalized workplaces.

The ECB is in the process of deploying Windows 10 as a replacement desktop operating system (currently Windows 7).

1. The Tenderer is expected to supply ("re-sell") IT End-user Computer Hardware and associated equipment that includes but is not limited to:

- Laptop Computers (on request pre-imaged with customer supplied image),
- Desktop Computers (on request pre-imaged with customer supplied image),
- Thin-client devices,
- monitors,
- Electronic Displays/Electronic Whiteboards,
- desk-side printers and desk-side multi-functional devices (capable of copying, printing and scanning),
- smartphones,
- tablet devices,
- options, extensions, accessories and associated equipment for Laptop and Desktop computers, Thin-clients, Monitors, Printers, Tablets and Smartphones (e.g. port replicators, adaptors, keyboard, mouse, ergonomic devices, DVD burner, encrypted hard drive, encrypted USB sticks, headset, lock, privacy filter, webcam, scanners, carrying cases, RAM, HDD, DVD, USB keys etc.),
- minimum 3 (extendable up to 5) years original manufacturer extended warranty for all products and equipment procured via this tender.

2. The Tenderer is expected to supply the following services:

— Secure Storage Service:

The Tenderer is expected to provide secure storage services within a distance that allows transport and reception of goods to and from Frankfurt am Main within max. 1 business day. These services shall support the secure storage of IT devices for the period of temporary non-ECB-usage (either directly after delivery or at any point in time required). The secure storage area shall fulfill all requirements for safe and secure storage areas including related access control and loading/unloading area.

— Secure Transport Service:

On request, the Tenderer is expected to provide secure transport services for IT devices between the secure storage area and the ECB locations in Frankfurt am Main.

— Optional: Provision of Maintenance and Support Services:

On request, the Tenderer is expected to provide Maintenance and Support Services to IT End-User Computer Hardware and associated equipment, in particular covering the following: all existing (described in Annex 1 "Technical Specifications", Chapter 6.2) and future acquired desktop and laptop computers, printers and optionally multi-functional peripheral devices (capable of copying, printing and scanning) and other devices/ accessories covered by this document, including associated equipment, options, extensions and accessories.

— Optional: IT End-user Hardware Roll-out Services:

On request, the Tenderer is expected to provide further support services, in particular installation, roll-out and replacement services for personal desktop and laptop computers, desktop monitors, desk-side printers and other devices/accessories covered by this document. For other devices not procured via this tender, the task description and price per roll-out would be the subject of a separate agreement between the Tenderer and the ECB.

— Optional: System Integration Services (Consultancy Services related to IT End-user Hardware Equipment):

On request, the Tenderer is expected to provide further system integration services related to the IT end-user hardware equipment. This will comprise of consultancy services for the provisioning, problem determination and/or further development of IT end-user hardware equipment related services.

• Optional: Transition Services:

On request, the Tenderer is expected to provide transition services related to the IT end-user hardware equipment at the end of the contract in order to allow for seamless service provisioning with a tendered new service provider.

The ECB may exclude tenderers from participation at any time if:

(a) they are bankrupt or being wound up, are having their affairs administered by the courts, have entered into an arrangement with creditors, have suspended business activities, are the subject of proceedings concerning these matters, or are in any analogous situation arising from a similar procedure provided for in national legislation or regulations;

(b) they have been convicted of an offence concerning their professional conduct by a judgment which has the force of "res judicata";

(c) they have been guilty of grave professional misconduct;

(d) they have not fulfilled obligations relating to the payment of social security contributions or the payment of taxes in accordance with the legal provisions of the country in which they reside or with those of the country of the Contracting Authority or those of the country where the contract is to be performed;

(e) they have been declared by a court or an arbitration tribunal to be in serious breach of contract for failure to comply with their contractual obligations following another tender procedure;

(f) their management, staff or agents are subject to a conflict of interests;

(g) they are guilty of misrepresentation in supplying the information required by the ECB;

(h) they contact other tenderers with the purpose of restraining competition.

Tenderers must certify that they are not in any of the situations listed above by signing the relevant documentation relating to this procedure and provide the evidence requested therein. In the case of groupings, all members must fulfil these conditions. If such circumstances arise in the course of the procedure, the tenderer concerned shall inform the ECB thereof without undue delay.

The ITT describes how Tenderers have to prepare and submit their offers (see Chapter II-III), describes the evaluation and award process (see Chapter IV), explains how the ECB will inform the Tenderers about the outcome of the procedure (Chapter V) and lays down general rules to be observed by all Tenderers (Chapter VI).

The Technical Specifications (Annex 1 to the ITT) describe the ECB's functional and technical requirements. The Tender specifications will form an integral part of the Contract, together with the tender submitted by the successful Tenderer(s).

The draft framework agreement (Annex 2 to the ITT) specifies the ECB's legal terms and conditions for the performance of the contract. It will form the basis for the contractual relationship with the successful Tenderer. The Tender submission form (Annex 3 to the ITT) is a questionnaire to be completed and signed by Tenderers in order to assess their eligibility to participate in this procedure and their capacity to perform the contract. The Technical Offer (Annex 5 to the ITT) is a questionnaire that will help the ECB to assess the offers received.

The Financial Offer (Annex 4 to the ITT) is a table that Tenderers use to submit their financial offer. In addition it provides an overview of the existing equipment and software currently in use at the ECB.
