TIPS-0007-SYS - Alignment of TIPS XSD specification to EPC SCT Inst



Description:

TIPS-0007-SYS is about closing a few gaps identified in the message specifications with respect to the SCT Inst scheme, for compliance with the reference Implementation Guidelines specifications document.

TIPS-0008-URD - CMB limit utilisation reset



Description:

TIPS-0008-URD concerns a new functionality for the CMB that was not foreseen in the URD. A CMB limit in TIPS represents a payment capacity granted to a Reachable Party which can be modified either by updating the CMB limit or by increasing or decreasing liquidity by means of instant payment transactions.

TIPS-0010-SYS Routing Enhancements



Description:

TIPS-0010-SYS encompasses a twofold change: Firstly, to allow each Party to define two different Party Technical Addresses, one to be used for notifications and one to be used for reports, and secondly, to allow each Party to define multiple Party Technical Addresses to be used to deliver multiple copies of the same report.
