



User testing

Project timeline – 12 weeks until user testing completion (i.e., 20 September 2024)





ECMS User Testing – Key milestones

Date	Description
24 June	The T2S and CLM services are reconnected to ECMS
24-30 June	The preparation week, followed by Migration Weekend Dress Rehearsal (29/30 June 2024) will be conducted as part of migration test 9
1 July	The Community Testing Phase (CTP2e) is ongoing with T2S and CLM interconnection
1-18 July + 19 Aug 6 Sept.	Live timing testing window during which the schedule applied in production will be applied in User Testing environment (except for Fridays)
23 August	Deadline for completion of ECMS Fundamental Test Case (FTC) execution and submission of test outcome to the National Service Desk
6 September	Functional testing completed and handover the environment for migration test 11
9-20 September	Migration test 11
20 September	The User testing execution phase completed (Formal but not actual end of testing)

ECMS User Testing – Community testing phase (CTP2e)

Date

Description

1 July – 6 Sept.

CTP2e - Functional testing of different ECMS modules shall be conducted until the start of migration test 11 on 09/09/2024

From 1 July

The Community Testing Phase (CTP2e) with T2S and CLM interconnection:

- (De) Mobilisation/cancellation of Marketable Assets
- · Cash as collateral
- · Corporate Actions Mandatory Events
- · Credit Claims
- · Global Credit and Collateral position
- Monetary Policy Operations Standing Facilities
- · Pool position and projections

1 July

The CPTYs are advised to **wait for the greenlight** of their respective NCBs on the completion of migration weekend testing activities before resuming functional testing on 01/07/2024

ECMS User Testing – Community testing phase (CTP2e)

Prom 1 July

CPTY testing of following modules can start:

1. Provision of Reference Data to T2S and TPA
2. Relocation of Marketable Assets and Autocollateralisation
3. Statements and reporting for those statements/reports for which no critical issues are open

Testing of TPA is currently planned to start

Testing of Multipooling is currently planned to start from end of July

- The Counterparties (CPTYs) are advised to wait for the greenlight of their respective NCBs before starting the testing for the above functional domains
- The CPTYs shall take note of open software defects for all the functional domains in the annex of the testing conditions document published on a fortnightly basis

ECMS User Testing – CTP2e – Testing campaigns Open Market Operations (OMOs)

Timeline: 8 to 19 July 2024



Objective

- Liquidity Absorbing Operations (LAO)
 → Fixed Term Deposit (fixed/standard rate).
- Liquidity Providing Operations (LPO)
 → Main Refinancing Operations (MRO) fixed and variable rate
- Non-Euro operation (i.e., US Dollar operation)
- Long-Term Refinancing Operations (LTRO)
- · Early Repayments on LTRO

- If needed, an additional mini-campaign can take place later in July.
- As from August, the OMO testing will be performed in Production-like conditions.

ECMS User Testing – CTP2e – Testing campaigns Corporate Actions Elective Events

Timeline: 1 to 30 August 2024



Prerequisite

- Stabilise the testing of CA mandatory events by end July (i.e. FTC).
- Resolve all the critical issues for the testing of elective events by end of July



Objective

- The NCBs/CSDs/CPTYs to focus on the testing of CA elective events
- Blocking/critical issues identified in the campaign reported via National Service Desk shall be handled with high priority

ECMS User Testing – CTP2e – Testing campaigns

Statements and Reporting weeks

Timeline: 29 July to 9 August 2024



Prerequisite

 The needed subscriptions and configuration for statements and U2A reports to be set up



Objective

- The NCBs/CPTYs to focus on the testing of statements and U2A reports, and report identified issues
- Blocking/critical issues identified in the campaign reported via National Service Desk shall be handled with high priority

ECMS User Testing – CTP2e – Testing campaigns

- For CCBM testing cases, Home Central Bank (HCB) and Correspondent Central Bank (CCB) shall coordinate to establish the appropriate test condition
- CPTYs shall contact its own Home Central Bank (HCB) to get the test data (e.g. ISINs, accounts, potential CA events) for any cross-border testing



Volume tests

- 22 July 16 August 2024
 Volume tests can be organised during this time window where the users can test if their system can process a high-volume responses from ECMS by sending lot of instructions to the ECMS
- CPTYs who are interested in volumetric testing should contact their NCB
